Date: May 16, 2022

Attached is the summary of revenue and expenditures for the month of April 2022 for the Education and Operations and Maintenance funds. The Cash and Investment Balances Reports are also attached.

For April, Education fund revenues were \$8.1 million and Education fund expenditures totaled \$10.6 million; expenditures exceeded revenues by \$2.5 million. The Operations and Maintenance fund revenues were \$650K and expenditures were \$1.18 million; expenditures exceeded revenues by \$540K.
