**PROFESSIONAL SERVICES AGREEMENT**

THIS AMENDMENT No. 2 TO UNIVERSITY CONTRACT No. 231009 is made and entered into, by and between SPRINGFIELD PUBLIC SCHOOL DISTRICT 186, STUDENT SUPPORT SERVICES, hereinafter collectively referred to as (“School District”) and THE BOARD OF TRUSTEES OF SOUTHERN ILLINOIS UNIVERSITY, a body politic and corporate of the State of Illinois, located at Carbondale, Illinois, for an on behalf of its School of Medicine (hereinafter referred to as “University”).

**RECITALS:**

WHEREAS, School District and University have hereto entered into University Contract No. 231009, effective July 1, 2022 and hereinafter referred to as the (“Agreement”); and

WHEREAS, School District, in order to enhance the provision of services which are being delivered by the School District, desires to acquire the professional services of an Audiologist through the School of Medicine’s Department of Otolaryngology; and

WHEREAS, the University and School District now desire to amend the Agreement as described herein.

NOW THEREFORE, in consideration of the mutual promises and undertakings hereinafter set forth, the parties hereto do mutually agree as follows.

1. Section 4.1 shall be amended to read:

“Compensation for Services of Professional. As compensation for all duties and obligations set forth herein, School District shall pay to University a contract fee computed at the hourly rate of FIFTY (\$50.00) DOLLARS.”

2. Section 4.3 shall be amended to read:


“Limitation on Compensation. The preceding provisions of this Article IV notwithstanding, however, the compensation which the Parties reasonably

anticipate that School District will pay to the University under and pursuant to this Agreement will not exceed, an annual aggregate sum of NINE THOUSAND (\$9,000.00) DOLLARS.

- 3. Except as hereinabove modified, the terms and conditions of the original Agreement and any subsequent amendments hereto shall remain in full force and effect.
