

# AMENDMENT AGREEMENT TO THE SERVICES AGREEMENT

This Amendment Agreement to the Services Agreement (this "Amendment") is by and between Springfield Public Schools District 186 (the "Customer" or "you") and DotCom Therapy, Inc. ("DotCom") and will become effective as of the signed completion of this agreement by both parties (the "Amendment Date").

### BACKGROUND

The Company and Customer are parties to the current completed Services Agreement and any applicable Amendments to that Service Agreement.
