



## AMENDMENT AGREEMENT TO THE SERVICES AGREEMENT

This Amendment Agreement to the Services Agreement (this "Amendment") is by and between Springfield Public Schools District 186 (the "Customer" or "you") and DotCom Therapy, Inc. 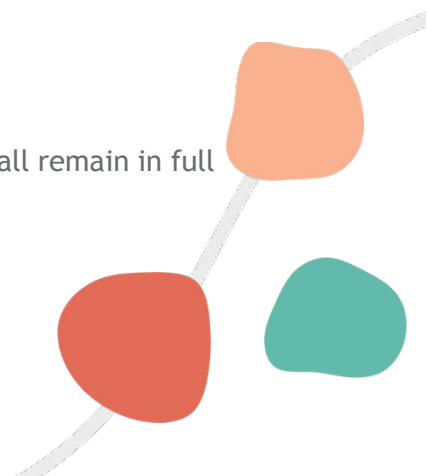
In consideration of the mutual agreements set forth in the Amendment, the parties agree as follows:
